Copies of the Andhra Pradesh Appropriation (Vote-on-Account) Act No.4 of 2019 relating to the Budget for 2019-20 are forwarded herewith to all Heads of Department and Departments of Secretariat.

Under Article 206 of the Constitution, Demands for Grants for 2019-20 were presented to the State Legislature on 05-02-2019 and an Advance Grant (Vote-on-Account) for a part of the year (roughly equal to the expenditure likely to be incurred during the first four months of the financial year) has been obtained from the Legislature vide the Andhra Pradesh Appropriation (Vote-on-Account) Act No.4 of 2019 appended to this order. The Budget Estimates of expenditure for the entire financial year 2019-20 on the basis of which the 'Vote on Account' has been obtained, are being communicated separately to all the Heads of Departments and Departments of Secretariat, etc.

3. The Budget for the full year 2019-20 will again be presented to the State Legislature in due course.

4. All the Heads of Department and other Chief Controlling Officers are requested to see that until further orders, the total expenditure to be incurred in the year 2019-20 under each Demand does not exceed the amounts specified against it in the AP Appropriation (Vote-on-Account) Act, 2019.
