The attention of all the Departments of Secretariat /Heads of Departments / District Collectors is invited to the reference 10th cited, wherein, earlier orders were issued for further continuation of ban orders imposed on purchase of "Furniture" by Government departments upto 31.05.2019.

2. Government have reviewed the matter and due to stringent ways and means position of the State, is hereby decided to continue the ban on purchase of furniture till 31.05.2020 w.e.f. 01.06.2019. Accordingly, all the Government departments/ Offices are directed that no furniture shall be allowed to be purchased by Government Departments /Offices except Hospitals, Residential Schools, Residential Colleges, newly created offices/Colleges, Offices that are relocated, and Constitutional Authorities i.e. Governor's Secretariat, High Court of Andhra Pradesh till 31.05.2020.
