**ORDER:**

In the Government Order first read above, the Government have revised the salaries of the employees of the State Government. In para 8(b) of the said G.O., it is stated that separate orders will be issued in regard to the officers and staff of the High Court of Judicature, Andhra Pradesh.

The Registrar, High Court vide his letters second read above, forwarded to the Government, the draft of the Andhra Pradesh High Court Officers and Staff Scales of Pay Rules, 2006 as approved by the Chief Justice of Andhra Pradesh for issue in exercise of the powers conferred under Article 229 of the Constitution of India. The rules have been finalized in consultation with the High Court.

3. Under the provisio to clause (2) of Article 229 of the Constitution of India, the Governor of Andhra Pradesh hereby accords approval to the said Andhra Pradesh High Court Officers and Staff Scales of Pay Rules, 2006 which are annexed hereto.

## **NOTIFICATION**

In exercise of the powers conferred by clause (2) of Article 229 of the Constitution of India and with the approval of the Governor of Andhra Pradesh, the Chief Justice, High Court of Andhra Pradesh, hereby makes the following rules in respect of the salaries and allowances of the officers and staff of the High Court of Andhra Pradesh.

## **RULES**

### 1. SHORT TITLE, COMMENCEMENT AND APPLICATION:

- (a) These rules may be called the Andhra Pradesh High Court Officers and Staff Scales of Pay Rules, 2006.
- (b) They shall be deemed to have come into force on and from the 1<sup>st</sup> July, 2003 with the monetary benefit from the 1<sup>st</sup> April, 2005.
- (c) These rules shall apply to all the employees of the High Court whether temporary, regular or permanent appointed before the 1<sup>st</sup> July, 2003.

### 2. SALARIES OF THE OFFICERS AND STAFF OF THE HIGH COURT:

- (a) The existing posts in the Andhra Pradesh High Court Service, the existing and revised scales of pay applicable to them shall be as specified in Schedule-I appended to these rules.
- (b) For purposes of pay and allowances, the posts in the Andhra Pradesh High Court Service shall correspond to the posts in the Secretariat as shown in Schedule-II(A) appended to these rules except the posts of Registrar General, Assistant Librarian, Overseer, Computer Operator, Assistant Overseer and Telex Operator, which are shown in Schedule-I I(B).

**3. PRINCIPLES FOR FIXATION OF PAY AND OTHER MATTERS CONSEQUENT THERETO:**

Subject to the provisions of rule 2, the rules and orders applicable to Government employees in the fixation of pay in the revised pay scales of 2005 and in all matters consequential or incidental thereto shall mutatis mutandis apply to the holders of the corresponding posts in the Andhra Pradesh High Court Service except that the period of six months allowed for exercising option shall be reckoned from the date of publication of these rules in the Andhra Pradesh Gazette.

**4. INTERPRETATION:**

All questions relating to interpretation of these rules shall be decided by the Chief Justice with the Approval of the Governor of Andhra Pradesh,
